Sub: Non-applicability of Regulation 27(2)(a) as per Regulation 15(2) of the SEBI (LODR) Regulations, 2015

This is to inform you that as per provisions of Regulation 15(2)(a) of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, Regulation 27 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 is not applicable to the Company for the Financial year 2020-21, as the paid-up capital and net worth were less than Rs. 10 Crores and Rs. 25 Crores respectively as on 31st March, 2022.
